

2024-25 GCU-FUNDED INSTITUTIONAL AID SCHOLARSHIPS

for New Freshman Students

Effective May 1, 2024



At Grand Canyon University, we offer generous scholarship opportunities to help make a private Christian education affordable. GCU's annual traditional campus tuition rate is \$16,500 for both in-state and out-of-state students. On average, a traditional campus student qualifies for approximately \$7,300 in GCU-funded scholarships for the academic year, which reduces tuition by almost half.¹

In 2022, GCU's traditional campus students received nearly \$180 million in scholarships. To maintain a GCU-funded institutional scholarship each year, students must be an admitted campus traditional undergraduate student and meet scholarship requirements. The following GCU-funded academic scholarships are renewable annually and can be locked in for up to four years for most programs. Visit gcu.edu/CampusScholarships for more information.

High School Academic Scholarship Program

High School student scholarships are based on weighted or un-weighted high school GPA. Students may also qualify for some scholarships with an SAT/ACT score and a minimum un-weighted HS GPA of 2.5.

¹ Average tuition after scholarships is approximately \$9,200. Scholarships may be awarded based on sixth semester transcripts (high school transcripts submitted after Junior year of high school). When final official transcripts are received, GCU reserves the right to rescind or modify the scholarship if it is determined that eligibility was not achieved. GCU reserves the right to change or decline scholarship awards for any reason. If a student does not meet the minimum renewal criteria, their scholarship will be forfeited. Prices are based on the 2022-23 rate and are subject to change.

² The Chancellor Award scholarship level requires an unweighted GPA for eligibility.

³ If the student is admitted based on ACT or SAT, they will need a minimum unweighted high school GPA of 2.5 to be awarded the scholarship.

¹Travel reimbursement is only available to students who demonstrate their ability to meet admissibility for the traditional campus, plus one legal guardian, from a student's home city/state to Phoenix, Arizona. School/district/organization staff, faculty and/or personnel are also eligible. To participate, the program requires a signed MOU by both the student and parent/guardian or personnel, approval of travel dates by GCU and receipts submitted per GCU requirements. Travel reimbursement thresholds vary based on location and education sector. Only one form of travel will be reimbursed (air or ground). GCU does not reimburse hotel expenses, baggage costs, early check-in or travel insurance fees. Travel reimbursement usually occurs within 45 days.

To minimize debt, and graduate with the least amount of debt possible, GCU encourages students to accept the most beneficial sources of financial assistance first, such as scholarships, grants, work-study (if eligible), student worker positions and GCU's interest-free payment plan options. Compare the terms of federal loans before applying for private loans.

Pre-licensure nursing students who begin or resume attendance in Fall 2020 and beyond will be ineligible to utilize GCU institutional aid/scholarships for tuition and fees once accepted into the clinical portion of the program. Please note, not all GCU programs are available in all states and in all learning modalities. Program availability is contingent on student enrollment. Grand Canyon University is accredited by the Higher Learning Commission (hlcommission.org), an institutional accreditation agency recognized by the U.S. Department of Education.
