



2024-25 HIGH SCHOOL SCHOLARSHIPS GCU-Funded Institutional Aid

At Grand Canyon University, we offer generous scholarship opportunities to help make a private Christian education affordable. GCU's annual traditional campus tuition rate is \$16,500 for both in-state and out-of-state students. On average, a traditional campus student qualifies for approximately \$7,300 in GCU-funded scholarships for the academic year, which reduces tuition by almost half.¹

In 2022, GCU's campus students received nearly \$180 million in scholarships. To maintain a GCU-funded institutional scholarship each year, students must be an admitted campus traditional undergraduate student and meet scholarship requirements. The following GCU-funded academic scholarships are renewable annually and can be locked in for up to four years for most programs. Visit gcu.edu/CampusScholarships for more information.

High School Academic Scholarship Program

High School student scholarships are awarded off un-weighted or weighted GPA (with the exception of Chancellor). Students who have an un-weighted High School GPA of 2.5 or higher may also use their SAT or ACT score to qualify.

¹ Average tuition after scholarships is approximately \$9,200. Scholarships may be awarded based on sixth semester transcripts (high school transcripts submitted after Junior year of high school). When final official transcripts are received, GCU reserves the right to rescind or modify the scholarship if it is determined that eligibility was not achieved. GCU reserves the right to change or decline scholarship awards for any reason. If a student does not meet the minimum renewal criteria, their scholarship will be forfeited. Prices are based on the 2022-2023 rate and are subject to change.

² The Chancellor Award scholarship level requires an unweighted GPA for eligibility.

³ If the student is admitted based on ACT or SAT, they will need a minimum unweighted high school GPA of 2.5 to be awarded the scholarship.

¹ The average fee estimate includes the Canyon Connect book fees (six classes per academic year), activity fee, health and wellness fee, technology fee, parking fee and housing application fee. The average fee estimate does not include Program Premiums for majors such as engineering and nursing. ⁴ Travel reimbursement is only available to students who demonstrate their ability to meet admissibility for the traditional campus, plus one legal guardian, from a student's home city/state to Phoenix, AZ. School/district/organizations staff, faculty and/or personnel are also eligible. To participate, the program requires a signed MOU by both the student and parent/guardian or personnel, approval of travel dates by GCU and receipts submitted per GCU requirements. Travel reimbursement thresholds vary based on location and education sector. Only one form of travel will be reimbursed, air or ground. GCU does not reimburse hotel expenses, baggage costs, early check-in or travel insurance fees. Travel reimbursement usually occurs within 45 days.

Pre-licensure nursing students who begin or resume attendance in Fall 2020 and beyond will be ineligible to utilize GCU institutional aid/scholarships for tuition and fees once accepted into the clinical portion of the program. Please note, not all GCU programs are available in all states and in all learning modalities. Program availability is contingent on student enrollment. Grand Canyon University is accredited by the Higher Learning Commission (hlcommission.org), an institutional accreditation agency recognized by the U.S. Department of Education.
