

At Grand Canyon University, we offer scholarship opportunities to help make a private Christian education affordable. GCU's annual traditional campus tuition rate is \$16,500 for both in-state and out-of-state students.

In 2024, GCU's traditional campus students received \$176 million in institutional aid. To maintain a GCU-funded institutional scholarship each year, students must be an admitted campus traditional undergraduate student and meet scholarship requirements. The following academic scholarships are renewable annually and can be locked in for up to four years for most programs. Visit *gcu.edu/CampusScholarships* for more information.

Indirect Academic Scholarship Program

Transfer, GAP Year and High School International F-1 Visa Students

Students who are enrolling with GCU and are not eligible for the high school academic scholarship program (enrolled at GCU the semester following high school graduation), or students who are attending with an International F-1 Visa may be eligible for a transfer scholarship. A transfer scholarship is based on a student's unweighted high school GPA, their cumulative college transfer GPA if they have six or more college credits or their ACT/SAT scores. ACT/SAT scores require a minimum 2.5 unweighted high school GPA.

¹Scholarships may be awarded based on sixth semester transcripts (high school transcripts submitted after Junior year of high school). When final official transcripts are received, GCU reserves the right to rescind or modify the scholarship if it is determined that eligibility was not achieved. GCU reserves the right to change or decline scholarship awards for any reason. If a student does not meet the minimum renewal criteria, their scholarship will be forfeited. Prices are based on the 2025-26 rate and are subject to change.

- ² If the student is admitted based on ACT or SAT, they will need a minimum unweighted high school GPA of 2.5 to be awarded the scholarship.

¹Travel reimbursement is only available to students who demonstrate their ability to meet admissibility for the traditional campus, plus one legal guardian, from a student's home city/state to Phoenix, Arizona. School/district/organization staff, faculty and/or personnel are also eligible. To participate, the program requires a signed MOU by both the student and parent/guardian or personnel, approval of travel dates by GCU and receipts submitted per GCU requirements. Travel reimbursement thresholds vary based on location and education sector. Only one form of travel will be reimbursed (air or ground). GCU does not reimburse hotel expenses, baggage costs, early check-in or travel insurance fees. Travel reimbursement usually occurs within 45 days.

Grand Canyon University is accredited by the Higher Learning Commission (hlcommission.org), an institutional accreditation agency recognized by the U.S. Department of Education. Program availability varies and is not offered in all states or modalities. Pre-licensure nursing students who begin or resume attendance in Fall 2020 and beyond will be ineligible to utilize most GCU institutional aid/scholarships for tuition and fees once accepted into the clinical portion of the program.
