The CCSC scholarship helps make Grand Canyon University's already affordable education even more accessible for families seeking a faith-based college experience. HIGH SCHOOL STUDENT SCHOLARSHIPS

High school student scholarships are based on weighted or unweighted high school GPA. Students may also qualify for some scholarships with an SAT/ACT score and a minimum unweighted high school GPA of 2.5.

¹This award offers up to \$4,000 per academic year to students who graduate from one of GCU's CCSC participant high schools. The student must have attended the CCSC school all four years and have an unweighted GPA of 2.5 or higher to receive the full scholarship. Qualified students must be enrolled for 12 or more credit hours for each semester and be under the age of 21 at the start of their first semester at GCU. If the student did not attend all 4 years, the scholarship amount will be prorated based on the number of semesters the student completed at the CCSC high school. The student must graduate from the CCSC high school to receive the scholarship. Students over the age of 21 but under the age of 23 at the time of starting coursework with GCU may be eligible for an indirect CCSC scholarship. These awards are renewable annually for fall and spring semesters for up to eight semesters if the student maintains continuous full-time enrollment, joins a campus worship service weekly and meets the 20-hour community service project requirement each semester (40 hours per academic year), upholds the ethical and moral values by which GCU stands and maintains admissibility with GCU. Recipients of the CCSC award are ineligible for the Grand Canyon State Scholarship. This scholarship is subject to the Grand Canyon University CAP policy and cannot exceed your charges. Award and award amounts are based on the 2025-26 award year. This scholarship is only available for traditional, undergraduate on-campus students.

- ²The cost of attendance (COA) takes into account expenses beyond tuition, fees, and other costs paid directly to the university. It provides an aggregate of estimated expenses a student could incur during an academic year. Your academic year is determined by your modality (campus or online) and your program of study. Please visit our Cost of Attendance page at gcu.edu/COA
- ³ The Chancellor Award scholarship level requires an unweighted GPA for eligibility.
- ⁴ If the student is admitted based on ACT or SAT, they will need a minimum unweighted high school GPA of 2.5 to be awarded the scholarship.

- ⁶ Based on suite-style, triple occupancy room plus the residence hall minimum meal plan (Canyon \$1,700 Dining Dollars per semester). Prices based on 2025-26 rate and are subject to change.

- ⁷Course fees include books, Canyon Connect book fee of \$120 (six classes per academic year), supplies and equipment.
- ⁸ The average fee estimate includes the activity fee, health fee, technology fee, parking fee and housing application fee.
- ⁹ The Canyon Christian Schools Consortium award has been included above and the amount reflects the 'on campus' award and is subject to change based on the student's eligibility criteria.
- Travel reimbursement is only available to students who demonstrate their ability to meet admissibility for the traditional campus, plus one legal guardian, from a student's home city/state to Phoenix, Arizona. School/district/organization staff, faculty and/or personnel are also eligible. To participate, the program requires a signed MOU by both the student and parent/guardian or personnel, approval of travel dates by GCU and receipts submitted per GCU requirements. Travel reimbursement thresholds vary based on location and education sector. Only one form of travel will be reimbursed (air or ground). GCU does not reimburse hotel expenses, baggage costs, early check-in or travel insurance fees. Travel reimbursement usually occurs within 45 days.

To minimize debt, and graduate with the least amount of debt possible, GCU encourages students to accept the most beneficial sources of financial assistance first, such as scholarships, grants, work-study (if eligible), student worker positions and GCU's interest-free payment plan options. Compare the terms of federal loans before applying for private loans.

Pre-licensure nursing students who begin or resume attendance in Fall 2020 and beyond will be ineligible to utilize most GCU institutional aid/scholarships for tuition and fees once accepted into the clinical portion of the program. Review institutional aid limits (caps) in the "Institutional Aid" section of the University Policy Handbook.
